For amounts exceeding \$50,000.00, the fee shall be \$375.00 plus an additional \$100.00 for any amount over \$50,000.00 up to Nine Thousand Nine Hundred Ninety-Nine dollars & 99 cents (\$9,999.99) increment. (For example, \$50,001.00 to \$59,999.99, the fee will be \$475.00)

In addition to the above, a \$4.50 State mandatory permit fee will be added to permits for new construction, alterations, remodeling, decks, swimming pools, etc.

The above Building Permit Fees does not include any inspection fees that may be required under the Uniform Construction Code. That fee is \$100.00
