**AN ORDINANCE OF THE TOWNSHIP OF NEWPORT, COUNTY OF LUZERNE, COMMONWEALTH OF PENNSYLVANIA, APPROVING THE BUDGET AND SETTING THE TAX RATES FOR THE YEAR 2026**

**BE IT ORDAINED AND ENACTED, AND IT IS HEREBY ORDAINED AND ENACTED BY THE BOARD OF COMMISSIONERS OF NEWPORT TOWNSHIP, COUNTY OF LUZERNE, AND COMMONWEALTH OF PENNSYLVANIA.**

**THAT THE GENERAL FUND BUDGET FOR 2026, IN THE AMOUNT OF \$2,162,182 IS HEREBY APPROVED AND SUBMITTED, AND**

**THE REFUSE BUDGET FOR 2026, IN THE AMOUNT OF \$583,795.00 IS HEREBY APPROVED AS SUBMITTED; AND**

**THE RECYCLING BUDGET FOR 2026, IN THE AMOUNT OF \$66,999.00 IS HEREBY APPROVED AS SUBMITTED; AND**

**THE LIQUID FUELS BUDGET FOR 2026, IN THE AMOUNT OF \$122,850 IS HEREBY APPROVED AS SUBMITTED;**


**THE CAPITAL PURCHASE FUND BUDGET FOR 2026, IN THE AMOUNT OF \$60,745.00 IS HEREBY APPROVED AS SUBMITTED;**



EMERGENCY AND MUNICIPAL TAX	\$52.00
EARNED INCOME TAX, RESIDENT (PERCENT)	.5000
REALTY TRANSFER TAX (PERCENT)	.5000
PER CAPITA	\$5.00
