

**NEWPORT TOWNSHIP ORDINANCE NO. 1 Of 2000**

**AN ORDINANCE PROVIDING FOR THE COLLECTION, DISPOSAL AND REMOVAL OF RECYCLEABLES, DESIGNATING THE TOWNSHIP OF NEWPORT AS THE EXCLUSIVE COLLECTOR OF ALL RECYCLEABLE MATERIAL WITHIN THE TOWNSHIP, PROHIBITING THE COLLECTION OF RECYCLEABLE MATERIAL BY UNAUTHORIZED PERSONS, ESTABLISHING A FEE FOR RECYCLING BY THE TOWNSHIP, FIXING PENALTIES FOR VIOLATIONS THEREOF AND REPEALING INCONSISTENT OR CONFLICTING ORDINANCES OR PARTS THEREOF.**

**BE IT ENACTED AND ORDAINED** by the Board of Commissioners of the Township of Newport :

**Section 1: All recyclables accumulated within the Township of Newport shall be collected, conveyed and disposed of by the Township and the cost of said service shall be paid as provided in the "Fees" set forth in Section 2 hereof.**

**It shall be unlawful for any person to collect or convey over any of the streets or alleys of the Township or dispose of any recyclables accumulated in the Township unless authorized by the Township of Newport to do so.**

**Section 2: There is hereby imposed upon the owner and/or occupier of each parcel or piece of property within the Township of Newport, except the Mercy Medical Care Center, Ken Pollack Apartments and the Rock Street Development Apartments, an annual recycling fee in the amount of Twenty Five (\$25.00) Dollars per each separate dwelling unit. Said fee shall be due and payable at the time when the annual garbage fee shall be due.**

**Section 3: Any violation of this Ordinance shall be punishable by a fine not to exceed six hundred (\$600.00) dollars and/or imprisonment not to exceed thirty (30) days.**

**Section 4: The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or part thereof is declared to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or parts of this Ordinance.**

Section 5: All Ordinances or parts of Ordinances inconsistent herewith  
are hereby repealed.
