ATTORNEY SLUSSER HAD NOTHING TO REPORT

FINANCIAL OVERSIGHT REPORT:

MS. POLITO REPORTED THAT ALL OF THE DCED REPORTS HAVE BEEN FILED AND THAT THE TOWNSHIP WILL BE RECEIVING THE LIQUID FUELS FUNDS IN THE FIRST WEEK OF MARCH. MS POLITO ALSO STATED THAT THE YEAR TO DATE INCOME WAS \$58,220.05 AND THE EXPENSES WERE \$123,886.46.

TOWNSHIP MANAGER’S REPORT:

- A. ON TUESDAY JANUARY 14th CHRIS GOETZ FROM THE DEPARTMENT OF MUNICIPAL SERVICES RECONCILED THE TOWNSHIP’S MS-965 LIQUID FUELS REPORT FOR 2024. NEWPORT TOWNSHIP WILL BE RECEIVING THEIR 2025 LIQUID FUELS FUNDS DURING THE FIRST WEEK OF MARCH.
- B. ON WEDNESDAY JANUARY 15th EILEEN ROSEN FROM THE PENNSYLVANIA AUDITOR GENERALS OFFICE CONDUCTED AN AUDIT OF THE 2023 LIQUID FUELS FUND ACCOUNT. RESULTS OF THE AUDIT HAD NO FINDINGS.

- C. AS OF JANUARY 31ST 580, REFUSE STICKERS HAVE BEEN SOLD THAT IS AN INCREASE OF TEN FROM THE SAME TIME PERIOD LAST YEAR.
- D. I AM WORKING WITH ATTORNEY ROCKMAN ON REVISIONS TO THE BURNING ORDINANCE AND WE ARE ALSO WORKING ON A DUMPSTER ORDINANCE. THESE ORDINANCES WILL BE PREPARED IN TIME FOR THE FEBRUARY WORK SESSION.


