NEWPORT TOWNSHIP BOARD OF COMMISSIONERS

MEETING OF JANUARY 5,2026

PRESIDENT PAUL CZAPRACKI, CALLED THE MEETING TO ORDER AT 6:40 PM

ROLL CALL:

MR. HILLAN REPORTED THAT THE TOWNSHIP INCOME FOR 2025 WAS \$2,453,829.18. AND THE EXPENSES WERE \$2,505,198.98

TOWNSHIP MANAGER'S REPORT:

A. THE 2026 REFUSE AND RECYCLING BILLS HAVE BEEN MAILED. THE FEE FOR 2026 IS \$385.00 PER UNIT IF PAID BEFORE APRIL 30TH. PAYMENTS CAN BE MADE AT THE MUNICIPAL BUILDING, BY MAIL OR THIS YEAR THERE IS A NEW PAYMENT OPTION AVAILABLE ON OUR WEBSITE NEWPORTTOWNSHIP.ORG. B. ON MONDAY DECEMBER 22ND NEWPORT TOWNSHIP RECEIVED PERSONAL NOTIFICATION FROM SENATOR LISA BAKER INFORMING US THAT WE WERE AWARDED A \$105,000.00 STATEWIDE LSA GRANT FOR THE PLAYGROUND ON RAILRAOD STREET IN GLEN LYON. THIS
