NEWPORT TOWNSHIP BOARD OF COMMISSIONERS

MEETING OF NOVEMBER 5, 2018

PRESIDENT, PAUL CZAPRACKI, CALLED THE MEETING TO ORDER AT 6:00 PM AND STARTED WITH THE PLEDGE OF ALLEGIANCE TO THE FLAG OF THE UNITED STATES OF AMERICA.

ROLL CALL:

SOLICITOR'S REPORT:

ATTORNEY JOSEPH BARANKA REPORTED THAT THERE WAS A SETTLEMENT OFFER FROM THE ATTORNEY OF FORMER CHIEF OF POLICE, ALBERT VANDERMAR, FOR \$15,000. MR VISHNEFSKI MADE A MOTION TO ACCEPT THE SETTLEMET OFFER. THAT MOTION WAS SECONDED BY MS ZALESKI. ALL COMMISSIONERS PRESENT VOTED YES, AND THE MOTION PASSED. ATTORNEY BARANKA WILL INFORM MR VANDERMARK'S ATTORNEY THAT THE SETTLEMENT AMOUNT WAS APPROVED. WHEN RECEIVED, ATTORNEY'S FEES WILL BE DEDUCTED FROM THE SETTLEMENT AMOUNT. THE REMAINDER WILL BE CREDITED TO THE CONTINGENCY FUND SINCE THIS IS A ONE TIME UNUSUAL EVENT.

NEXT WILL BE THE DEVELOPMENT OF PROJECT SPECIFICATIONS AND PUBLISHING AN ANNOUNCEMENT FOR PROJECT BIDS. ACTUAL SIDEWALKS AND CURB WORK IS EXPECTED TO START MID 2019 AND CONCLUDE FALL OF 2019

- vi. OCD GLEN LYON DON BOWER CONSTRUCTION INITIATED PROJECT OCTOBER 23, 2018. ESTIMATED FINISH DATE NOVEMBER 10.. WEATHER PERMITTING

ASSIGNMENTS TO BE MADE BY THE DIRECTOR OF STREET DEPARTMENT OPERATIONS. MR ROKE MADE A MOTION TO APPROVE THE PROPOSAL MADE BY W. PETERS EXCAVATING. THAT MOTION WAS SECONDED BY MR VISHNEFSKI. ALL COMMISSSIONERS PRESENT VOTED YES, AND THE MOTION PASSED.
- f. MOTION TO REAPPOINT SEAN FARRELL TO A 5 YEAR TERM ON BOARD OF THE NEWPORT TOWNSHIP SEWER AUTHORITY. CURRENT TERM WILL EXPIRE JANUARY 1, 2019. MR ZYLA MADE A MOTION TO REAPPOINT MR FARRELL TO THE 5 YEAR TERM. THAT MOTION WAS SECONDED BY MR ROKE. ALL COMMISSIONERS PRESENT VOTED YES, AND THE MOTION PASSED.
- g. 2013 POLICE CRUISER SOLD ON MUNICIBID AUCTION FOR \$4,001. SALE WILL BE COMPLETED AFTER A DUPLICATE TITLE IS RECEIVED FROM HARRISBURG.
- h. A MOTION WAS MADE BY MR ZYLA TO APPROVE LUZERNE COUNTY, TAX CLAIM BUREAU AS TAX COLLECTOR FOR NEWPORT TOWNSHIP AT THE SAME FEE STRUCTURE CURRENTLY IN PLACE. THAT MOTION WAS SECONDED BY MR ROKE. ALL COMMISSIONERS PRESENT VOTED YES, AND THE MOTION PASSED.
- i. APPROVAL OF ORDINANCE NO 2018-6 AUTHORIZING REFUND OF REALTY TRANSFER TAX OF \$3,108.89 THAT WAS ERRONEOUSLY PAID BY NORFOLK SOUTHERN RAILWAY COMPANY. THEY WERE A TAX EXEMPT ENTITY ON OCTOBER 22, 2015 WHEN THE TAX WAS COLLECTED. NEWPORT TOWNSHIP SOLICITOR RESEARCHED THIS REFUND

- REQUEST AND FOUND IT TO BE WARRANTED. A MOTION TO APPROVE THE ORDINANCE WAS MADE BY MS ZALESKI. THAT MOTION WAS SECONDED BY MR ROKE. ALL COMMISSIONERS PRESENT VOTED YES, AND THE MOTION PASSED.
- j. NUMEROUS COMPLAINTS FROM RESIDENTS OF THE RIDGEVIEW SECTION REGARDING ON STREET PARKING CAUSING A DANGEROUS SITUATION FOR EMERGENCY VEHICLE FLOW. A REQUEST WILL BE MADE FOR PROFESSIONAL OPINIONS FROM FIRE AND POLICE DEPARTMENTS AS TO THE VALIDITY OF THE COMPLAINT. RESIDENTS ALSO ARE REQUESTING A REVIEW OF THE ORIGINAL COVENANTS THAT EXPIRED 8/31/2015 WHICH REFERENCE THE FORMATION OF A HOME OWNERS ASSOCIATION. MR WANCHISEN WILL SOLICIT INPUT FROM POLICE, FIRE, CODE ENFORCEMENT TO DETERMINE VALIDITY OF THE RESIDENTS' CONCERNS.
- k. A LAND DEDICATION CEREMONY FOR A 1,132 ACRE TRACT OF LAND TO THE PINCHOT STATE FOREST TOOK PLACE ON October 25. THIS EVENT WAS ATTENDED BY COMMISSIONERS JOHN ZYLA AND JOHN VISHNEFSKI AND TOWNSHIP MANAGER, PETER WANCHISEN. ALSO PARTICIPATING WERE REPRESENTATIVES FROM THE BUREAU OF FORESTRY, CINDY ADAMS DUNN, SECRETARY PENNSYLVANIA DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES, SENATOR JOHN YUDICHAK, REPRESENTATIVE GERALD MULLERY, REPRESENTATIVES FROM THE NORTH BRANCH LAND TRUST, SEVERAL MEMBERS OF THE NEWPORT TOWNSHIP COMMUNITY ORGANIZATION, AND OTHERS. A MAJOR FEATURE OF THIS LAND IS A MOUNTAIN BIKE / WALKING TRAIL THAT CONNECTS TO PENOBSCOT TRAIL AT A POINT IDENTIFIED AS THE WANAMIE EAST PARKING LOT.
