ORDINANCE - 1973-4

AN ORDINANCE OF THE TOWNSHIP OF NEWPORT PROHIBITING PARKING ON CERTAIN STREETS IN THE TOWNSHIP AND PROVIDING FOR A PENALTY FOR VIOLATIONS

The Board of Commissioners of the Township of Newport enacts and ordains:

SECTION 1: No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the following designated streets or portions thereof in the Township of Newport at any time:

ORDINANCE NO. 1971-2

AN ORDINANCE OF THE TOWNSHIP OF NEWPORT PROHIBITING PARKING ON CERTAIN STREETS IN THE TOWNSHIP AND PROVIDING FOR A PENALTY FOR VIOLATIONS

SECTION I: No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the streets of the said Township in any of the following places at any time:

- a. On the south side of West Main Street, Glen Lyon;
- b. On the north side of East Main Street, Glen Lyon;
- c. On the west side of Chestnut Street, Glen Lyon;
- d. On the north side of Coal Street, Glen Lyon;

- j. On the south side of Newport Street between Chestnut and Maple Streets, Glen Lyon;

- On the south side of Engle Street between North Spring and Third Streets, Glen Lyon;
- m. On the east side of Third Street, Glen Lyon;
- n. On the north side of Vandermark Road between Belles Road and Center Streets, Wanamie;
- o. On the east side of Center Street between Main Street and Belles Road, Wanamie;
- p. On the south side of Newport Street, Sheatown, between Robert Street and Newport Center;
- q. On the north side of Newport Street, Sheatown, between Robert Street and River Road;
- r. On the west side of Robert Street, Sheatown;

- s. On the north side of East Kirmar Avenue, Alden;
- t. On the south side of Charles Street, Sheatown;

SECTION II: No commercial motor vehicles, larger than the pick-up truck class, shall remain parked on any street in the Township of Newport between the hours of 9:00 P.M. and 6:00 A.M. on week days or at any time on Sundays.

SECTION III: Any person or persons violating any of the provisions of this Ordinance shall, upon summary conviction before a magistrate, be sentenced to pay a fine of not less than Two and 00/100 (\$2.00) Dollars nor more than Ten and 00/100 (\$10.00) Dollars and costs of prosecution, and in default of the payment thereof shall undergo imprisonment of not more than five (5) days.

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE 1973-4 OF THE TOWNSHIP OF NEWPORT PROHIBITING PARKING ON CERTAIN STREETS IN THE TOWNSHIP AND PROVIDING FOR A PENALTY FOR VIOLATIONS.

Be it enacted and ordained by the Township of Newport, Luzerne County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

1. Section 1 of Ordinance 1973-4 states: No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the following designated streets on portions thereof in the Township of Newport at any time:

The following shall be added to Ordinance 1973-4 Section 1:

- 64. On Newport Avenue, Alden.

- 67. The area to the left side and left front of the Newport Township Municipal Building, Wanamie.
- 2. The following section of Ordinance 1973-4 shall be deleted:

Section III: Any person or persons violating any of the

V. Any person or persons violating any of the provisions of this Ordinance shall, upon summary conviction before a Magistrate, be sentenced to pay a fine of not less then Ten (\$10.00) Dollars nor more than Twenty-Five (\$25.00) Dollars and costs of prosecution.

68. The Southerly side of Main street (S.R. 3004) Glen Lyon beginning 295 feet East of the Centerline of Rock Street and proceeding East for a distance of 190 feet.

ORDINANCE NO. ______ of 2007

An Ordinance of Newport Township amending certain provisions of Newport Township Ordinance No. 1973-4 (and all amendments thereto including, but not limited to Ordinance No 8 of 1991, Ordinance No 1 of 1993 and Ordinance No. 1 of 1996) prohibiting parking on certain streets and roadways in the Township and providing penalties for violations.

WHEREAS, a dry hydrant has been installed at the end of a public roadway known as "Inn Street" in the Lee section of Newport Township near an area known as "Chopak's Pond," and

WHEREAS, it is imperative that fire trucks have complete ingress and egress to the dry hydrant installed adjacent to an area known as Chopak's Pond, and

Whereas, the Township of Newport has determined that parking restrictions on this roadway would best serve the safety and welfare of it's residents in allowing constant access by fire trucks to the dry hydrant,

Now therefore, be it enacted and ordained by the Township of Newport, Luzerne County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

Ordinance 1973-4 of the Township of Newport, as subsequently amended, includes the following provision:

SECTION 1: No person shall park a motor vehicle or permit it to stand, whether attended or unattended, upon the following designated streets or portion thereof in the Township of Newport at any time;

Said Ordinance, as amended, shall be further amended to prohibit parking in the following designated area:

69. On the dirt roadway designated as "Inn Street" as indicated in Luzerne County Map Book 3, page 197, from the area adjoining PA Legislative Route No. 40031 to the end of the roadway adjacent to the dry hydrant next to an area known as Chopak's Pond

This Amendment shall take effect upon adoption and the placement of the appropriate "No Parking" signs on the designated roadway
